Business journal

Need one-on-one assistance? Librarians are always available, 365 days a year! Check out our schedule for more information. Different types of articles have unique citation requirements. First, determine the type of article you're referencing: is it from a magazine, newspaper, or academic journal? (If unsure, click here for tips.) Next, consult the style guide you'll be using to see which details should be included in your citation and in what order. Then, locate these details within the article's full text. Each publication formats its articles slightly differently, but here are some general guidelines on where to look: Author's name: Usually at the top of the first page or sometimes at the end of the article. Publication date: Typically found on the first page near the article title. Article title: Always located at the top of the first page. Periodical title: May appear at the top, bottom, or repeated throughout the pages (along with volume and issue numbers). Volume and issue numbers: In academic journals, usually listed after the periodical title. Page numbers: The entire article's page range is often listed after the volume and issue numbers. If not, look for the first page number, then scroll to the end of the article for the last page number. Page numbers may be in the top corners (right or left) or at the bottom of each page. DOI: May be found on the first page or in the header/footer information. See an example journal article below (click to enlarge). A Digital Object Identifier (DOI) is a standardized, unique number given by some publishers to identify publications. To find a DOI, look for "DOI:" followed by numbers on the first page and in the header/footer info. If you're missing a reference or have a DOI but no reference, try Crossref: click image to view larger. To use a DOI in a citation: Style guides used at APUS recommend using the most stable link available when citing electronic sources. If you can't find a DOI for your source, simply leave it out. APA requires including DOIs when available. Read more here. Bluebook has no designated preference regarding DOIs but suggests using the most stable electronic location available (Section 18.2.2). Chicago states that the CMS editors prefer to cite the most stable electronic location available. When citing sources, using a URL based on a DOI is generally preferred over the URL itself. According to MLA Handbook, citing a DOI is preferable when possible. Turabian also suggests using a DOI-based URL in citations instead of the actual URL. To find an article with a DOI, you can use the search terms "case studies" AND metaphors AND "organizational functionality". You can also try searching for specific metaphor-related keywords, such as "organization+ theory" AND metaphor*, or "brain metaphor AND management AND organization". It's recommended to use the Subject filter when narrowing down search results. Additionally, you can explore other search options, such as Morjan AND metaphor AND business AND case stud*. A case study analysis involves investigating business problems, examining alternative solutions, and proposing the most effective solution using evidence-based research. Before writing a case study, make sure to follow these steps: * Read and analyze the case thoroughly * Take notes and highlight key issues * Focus on 2-5 main problems and their impact on the organization To draft your analysis, include sections like an introduction, background information, alternatives, and proposed solutions. Use evidence from course readings, discussions, research, and personal experience to support your arguments. Once you've completed your first draft, review it for any gaps or inconsistencies in content or structure. Ensure your thesis statement is clear, and you've provided sufficient evidence.
